## Welcome

Northamptonshire Community Foundation is a unique charity which promotes and manages philanthropy.

We are here to create long term, sustainable funding for the voluntary and community sector. We are the leading independent grant-making charity in the county, and we are proud to have worked with our fund holders and donors to ensure projects make a sustainable impact on local needs, helping our donors make the most of their charitable giving.

We are now looking to recruit up to three trustees to join our Board from Autumn 2024. We welcome interest from people who have a love for, and strong connection to, Northamptonshire; who share our passion for the work of small local charities and community groups, and who have an enthusiasm for making a difference through charitable giving and philanthropy.

#### What we do

We deliver a variety of funding for the local voluntary and community sector and last year we saw a record grant-making year, awarding over £2.97 million.

We are dedicated to funding community-based action which improves the lives of our county's most disadvantaged people and communities. Poverty, unemployment, homelessness, domestic violence and social isolation are just some of the issues we strive to tackle each year.

We are focused on playing our part in delivering outcomes that meet the United Nations Sustainable Development Goals, in essence – 'The world's to-do list on our doorstep.' We are one of 47 Community Foundations across the UK which are playing a leading role in the development of community philanthropy and resources to sustain communities.

With the help and support of our donors and partners we can help communities to thrive, and be happy and healthy places to live. This foundation is for the county of Northamptonshire; all funding raised stays right here.

We are seeking to appoint new Trustees to join the Board at a crucial time of the organisation's development. We have recently published an updated Five-Year Strategy and the growth of our endowment and annual grant giving means there are new opportunities for achieving our mission and vision.

These include working with the Charity Commission on the Revitalising Trusts Programme, campaigning for a national philanthropy strategy, digital transformation, a clear focus on equity, diversity and inclusion and engaging with the two unitary authorities as we look forward to strengthening our partnerships for benefit of our communities.



# What we're looking for

We really want to hear from people with a broad range of lived and learned experience which would assist our Board and help us achieve our goals.

You don't need to have been a trustee already as we can give you induction and training, but you'll need the time and flexibility to take up the role, and the ability to commit to a minimum three-years term, and ideally six years. We're specifically looking to recruit a Trustee with one or more of the following areas of expertise, to compliment the existing skill base of our current Board of Trustees:

- Strong accountancy skills and financial expertise
- Expertise in Equality, Diversity and Inclusion, to support our work in and dedication to this space
- Expertise in environmental sustainability
- Specialism in digital skills, digital marketing and transformation

## What's involved

Our Board of Trustees acts collectively to govern Northamptonshire Community Foundation, ensuring we fulfil our purpose and mission and remain accountable to stakeholders and regulators.

Trustees agree and evaluate the Foundation's strategy, safeguard our reputation and ensure we are well run, financially stable and that our funds are properly invested. They also uphold our values and policies and are advocates for what we do. The full Board meets four times a year, plus an annual strategy away day. Trustees also join at least one committee or task group. On average we estimate the role takes up around half a day to a day a month depending on your roles and responsibilities.
